Central and Public Assistance Boards receive instruments of appointment

Port of Spain--- Senator the Honourable Donna Cox, Minister of Social Development and Family Services, presented Instruments of Appointment to thirty-eight (38) persons who will serve as Members of the Central and Local Public Assistance Boards. The presentation took place earlier today, May 22, at the Ministry's Head Office, St Vincent Street, Port of Spain. Also in attendance were Ag. Permanent Secretary of the Ministry, Ryan Ramcharan and Deputy Permanent Secretary, Wendy Guy-Hernandez.

The Appointees are required to attend Local Board and Assessment Meetings for the purpose of scrutinizing applications for Senior Citizens' Pension, Public Assistance and Disability Assistance Grant and Burial Assistance Grant and for making decisions on applicants on merits according to the Acts, policies, regulations and guidelines.

During her brief address, Minister Cox in thanking the members for their willingness to serve, told the new members that their appointments are valuable as they form part of the Ministry's continued efforts to achieving the national strategic goals outlined in the National Development Strategy (2016-2030)/ (Vision 2030) regarding the eradication of poverty and the enhancement of the lives of the vulnerable.

She further advised that they should familiarize themselves with the guiding legislations of the Social Welfare Division namely, the Senior Citizens Pension Act and the Public Assistance Act, as their core duties include controlling, directing and assisting the Local Boards in administering these core grants and where necessary, performing the duties of any of the Ministry's local boards.

In closing, Minister Cox took the opportunity to offer her full support to the Local Boards and wished all board members a successful and productive tenure.
