## SOCIAL DEVELOPMENT MINISTER CALLS ON SOCIAL WELFARE BOARD MEMBERS TO PUT PEOPLE FIRST IN THE EXERCISE OF THEIR DUTIES

**Port of Spain, March 23, 2025-** Senator the Honourable Donna Cox, Minister of Social Development and Family Services reminded Social Welfare Board Members of the Ministry's overarching mission to put people first as they exercise their duties. Minister Cox was addressing the Social Welfare Board Meeting/Training session, which was held on Saturday March 22, 2025 at BPTT's Hospitality Suite, Queen's Park Oval.

The training session was designed to reinforce the board members' understanding of their duties and obligations, as outlined in the Act, as well as to ensure a clear grasp of their roles and responsibilities, as these extend beyond just reviewing cases.

Minister Cox reminded the board members that care must be taken to avoid discrepancies, by giving matters before the board the scrutiny they deserve. She stated that, "another area (of concern) is the growing number of deferrals, as delayed decisions ultimately lead to delayed relief to clients who are in need." Minister Cox called on the board members to guard against complacency and poor decision making, by ensuring due diligence is incorporated into the decision making process. The Ministry, she affirmed, "is here to serve the most vulnerable and how we serve is just as important as the services that we provide."
